

Continuing Education Seminars

OALI hosts three continuing education seminars each year. These seminars are provided to enhance learning and networking and to offer a means for investigators to meet the continuing education requirements of the Oregon Board of Investigators. Those attending these seminars are sure to accumulate the required hours.

OALI begins the year with the Spring Seminar, held in mid-March. In June, OALI hosts the Summer Seminar in conjunction with the Annual Business Meeting. The Fall Seminar is held in October.

The costs to the members for the seminars vary, depending on the cost of the facility and the projected number of attendees.

Seminar Tapes

Each seminar is videotaped. These tapes provide an alternative means to earn continuing education credits. However, members are encouraged to attend our continuing education seminars.
